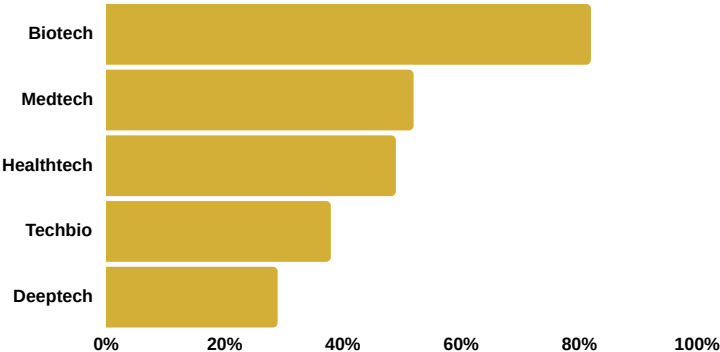

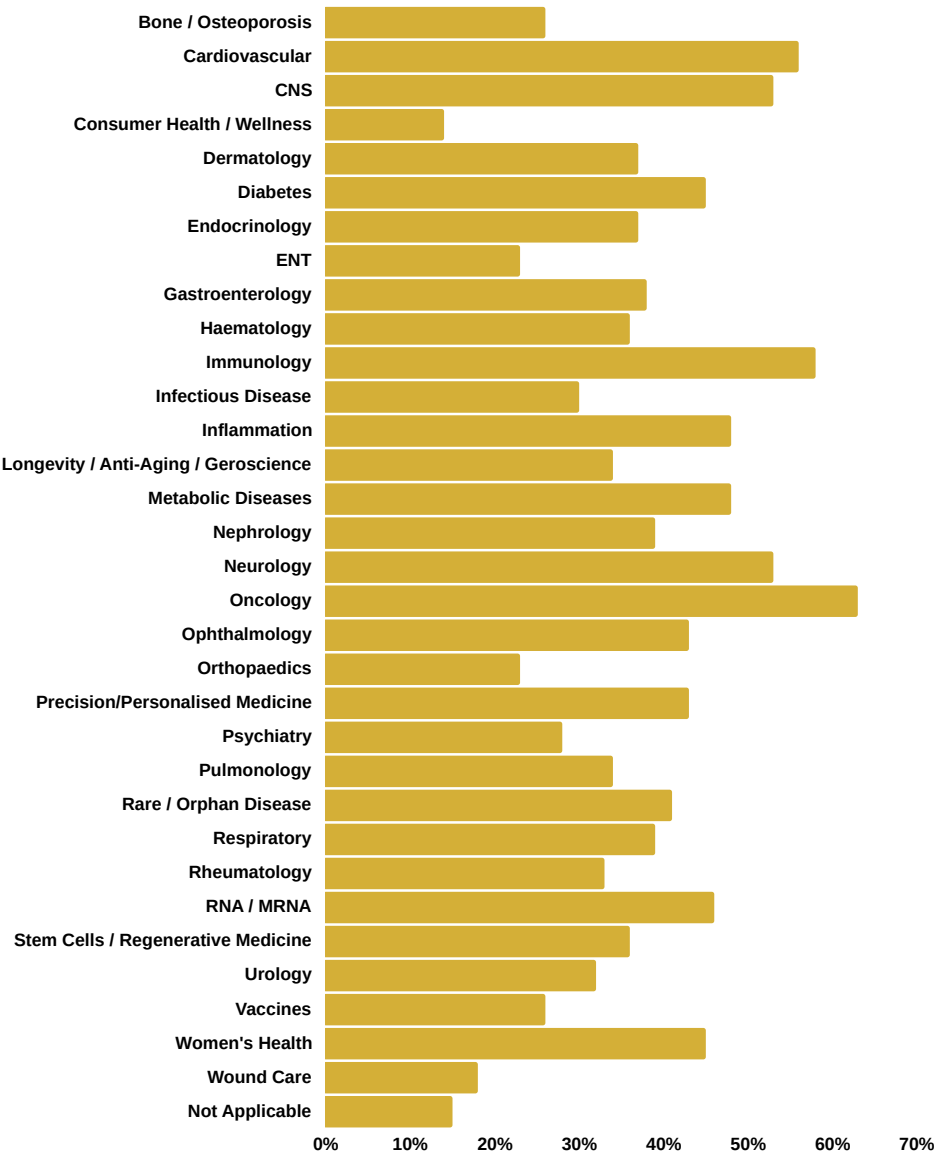


Company Stage Interest

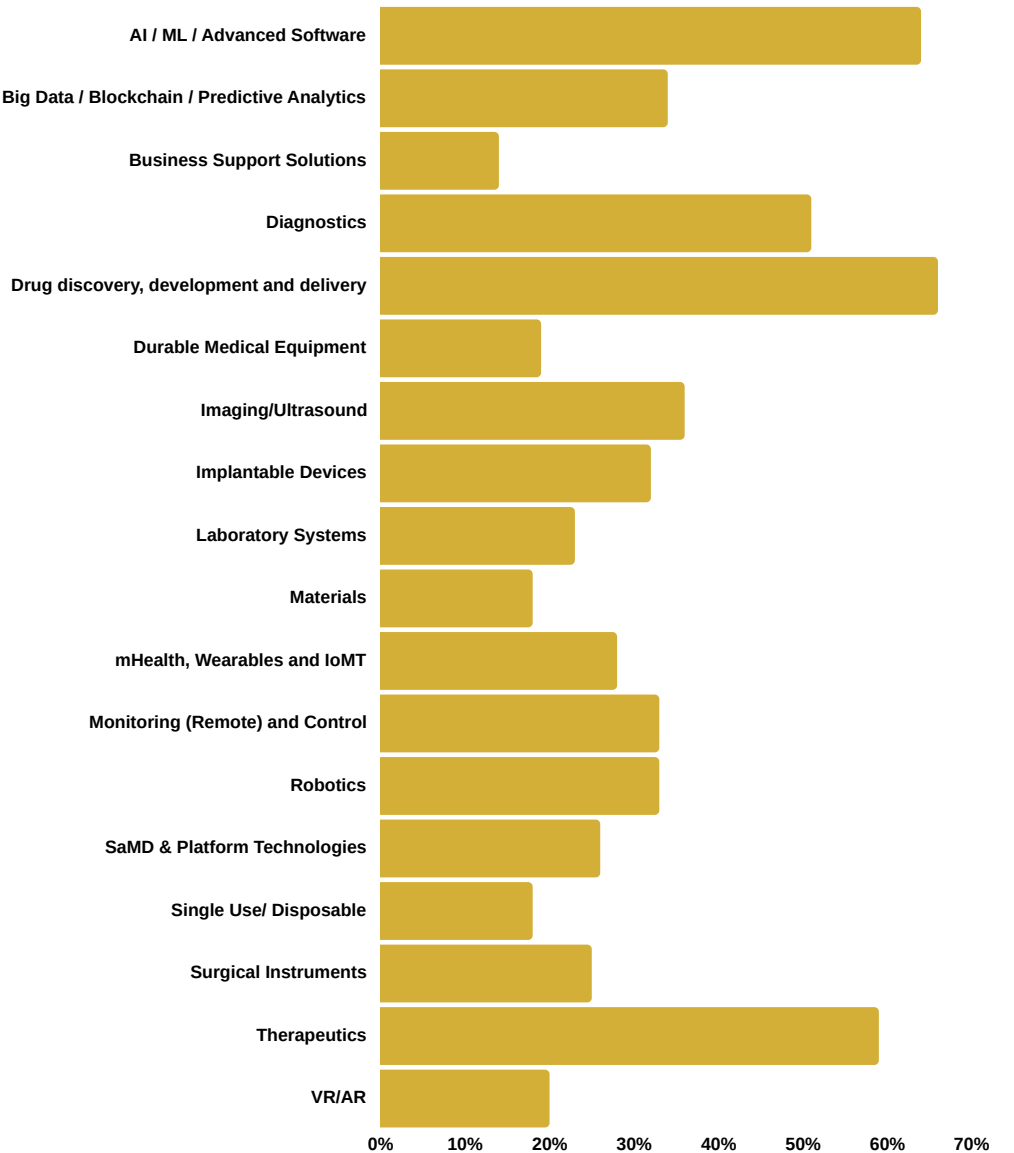

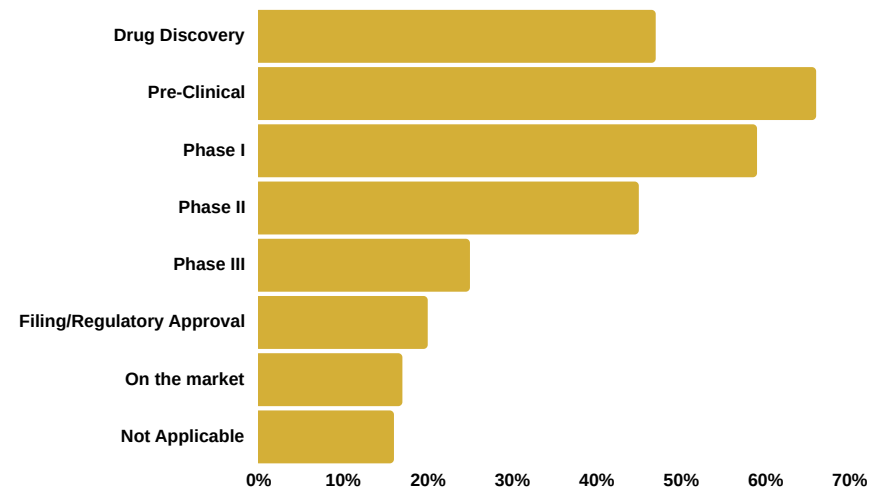

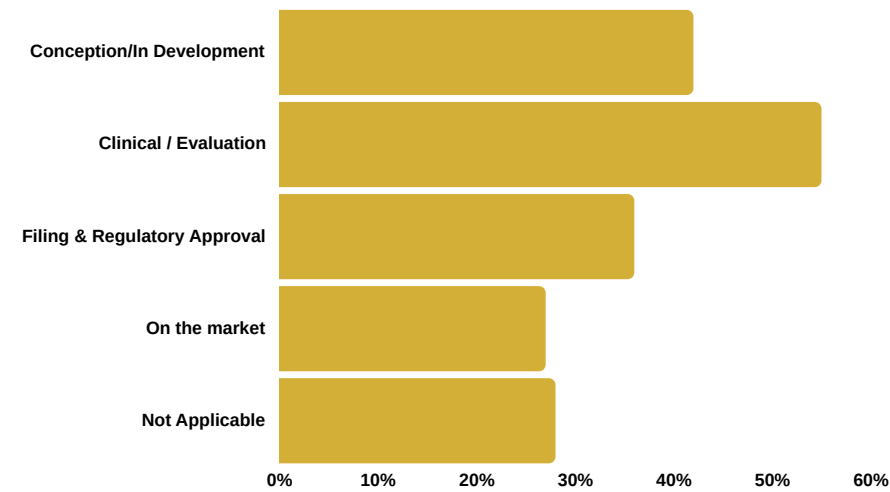

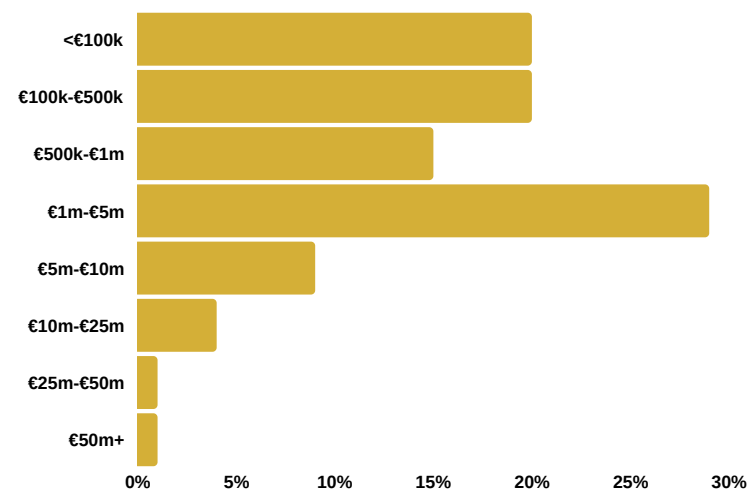
Biotech Company Stage Interest



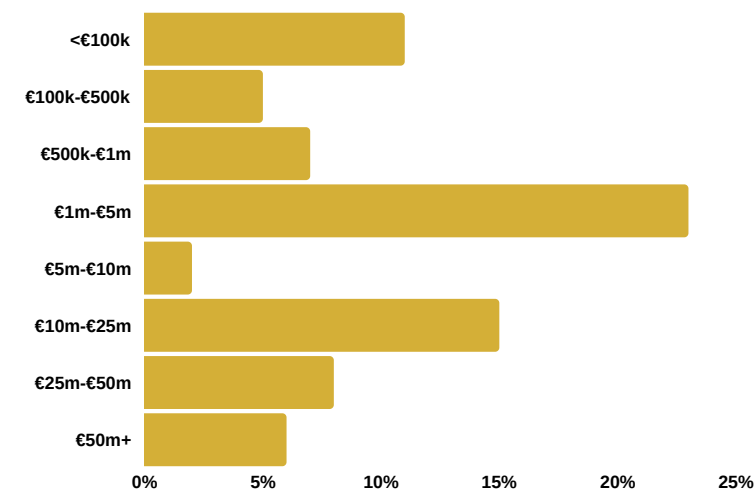
Healthtech/Medtech Company Stage Interest
