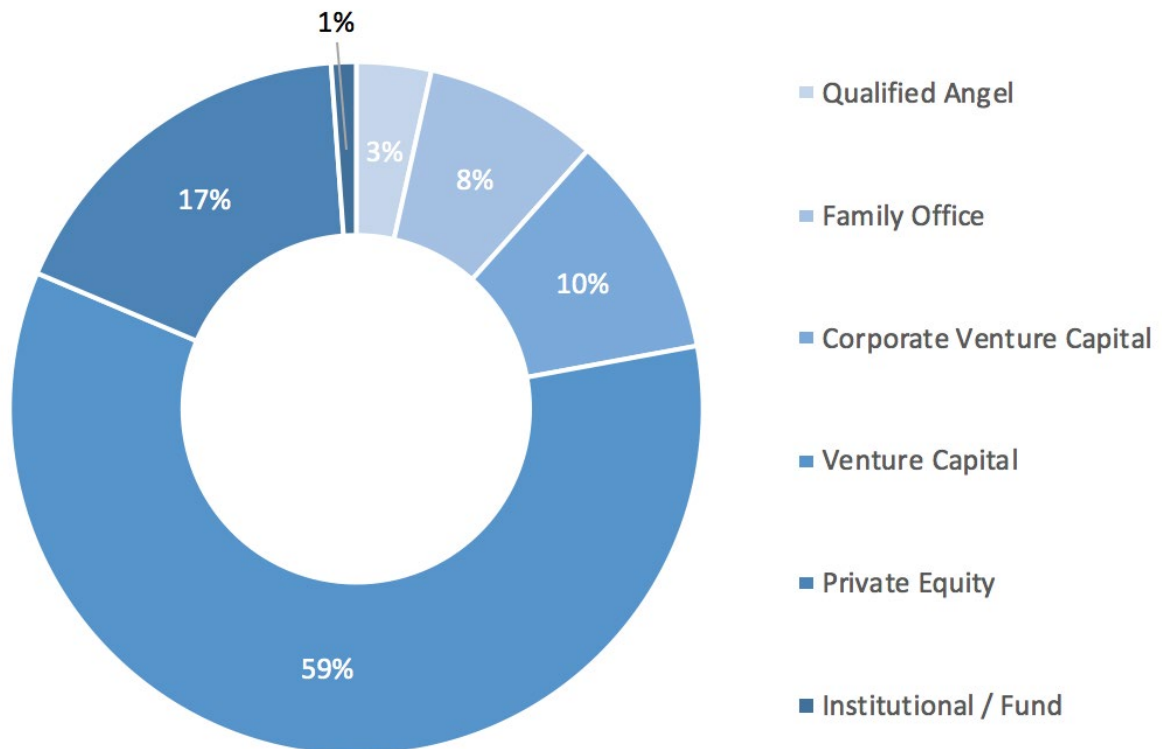

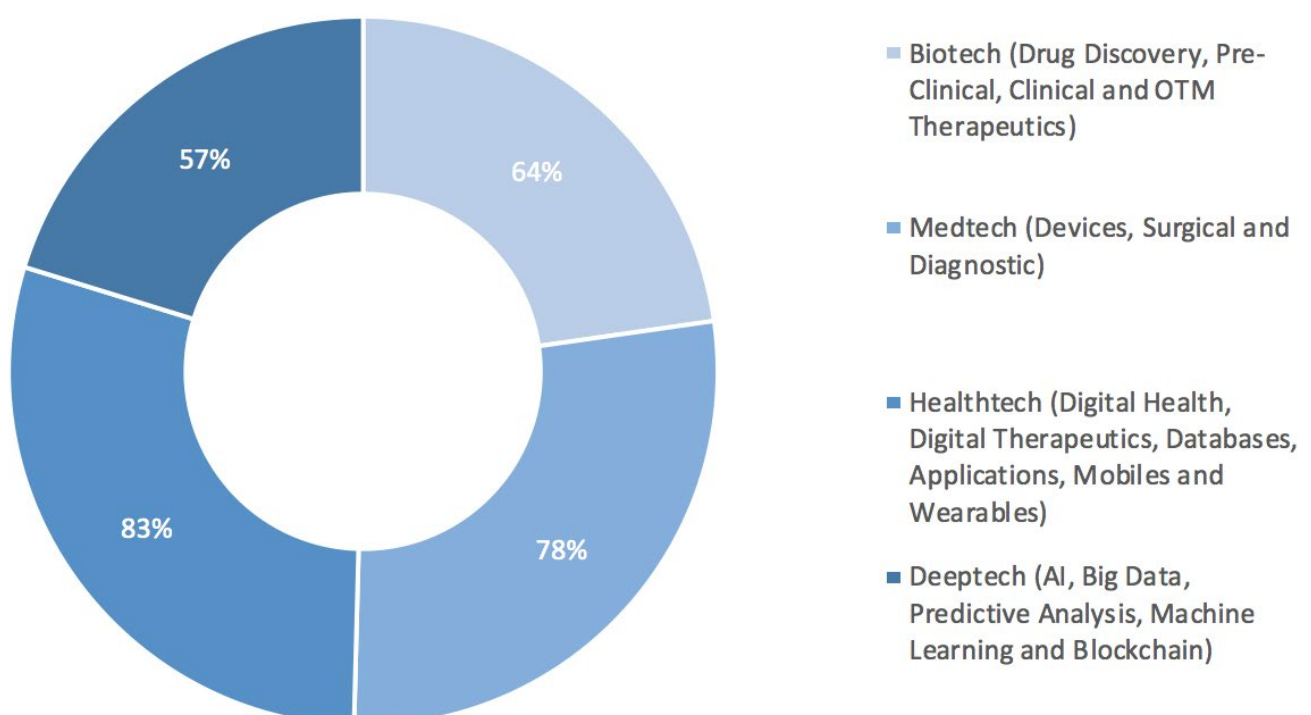


Investor and Strategic Interest

What type of investor are you?

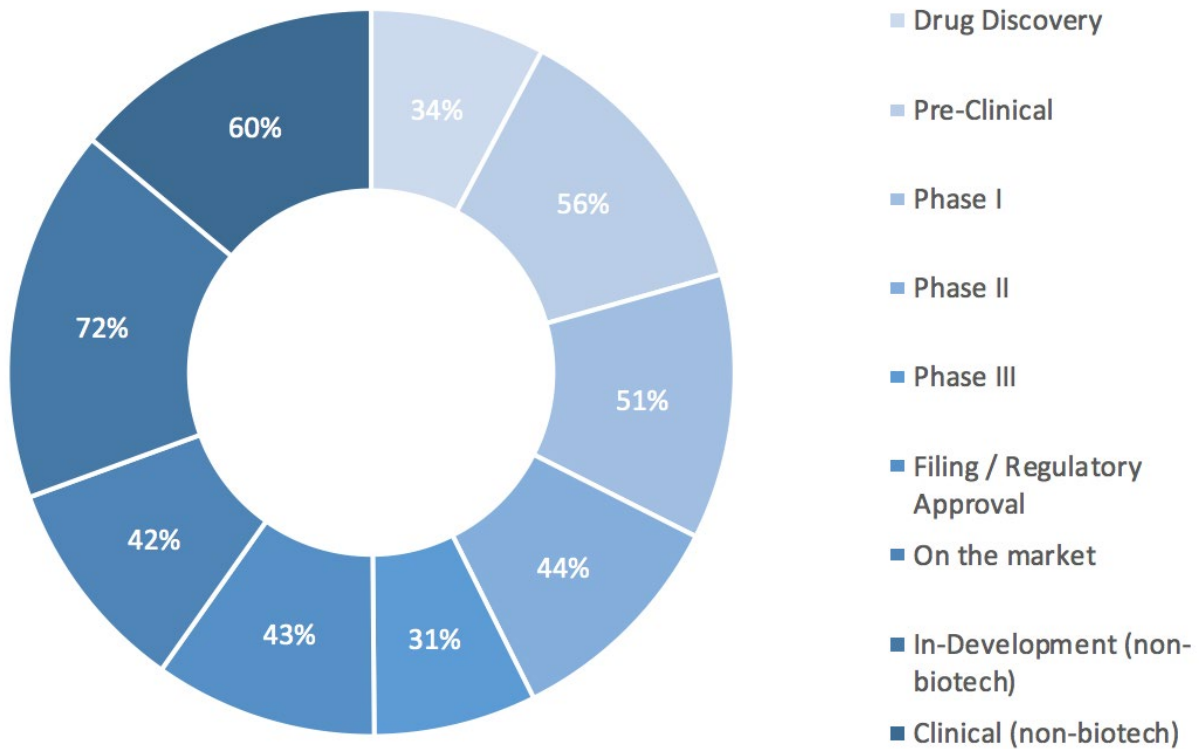


Which sector are you currently interested in investing / doing business in?

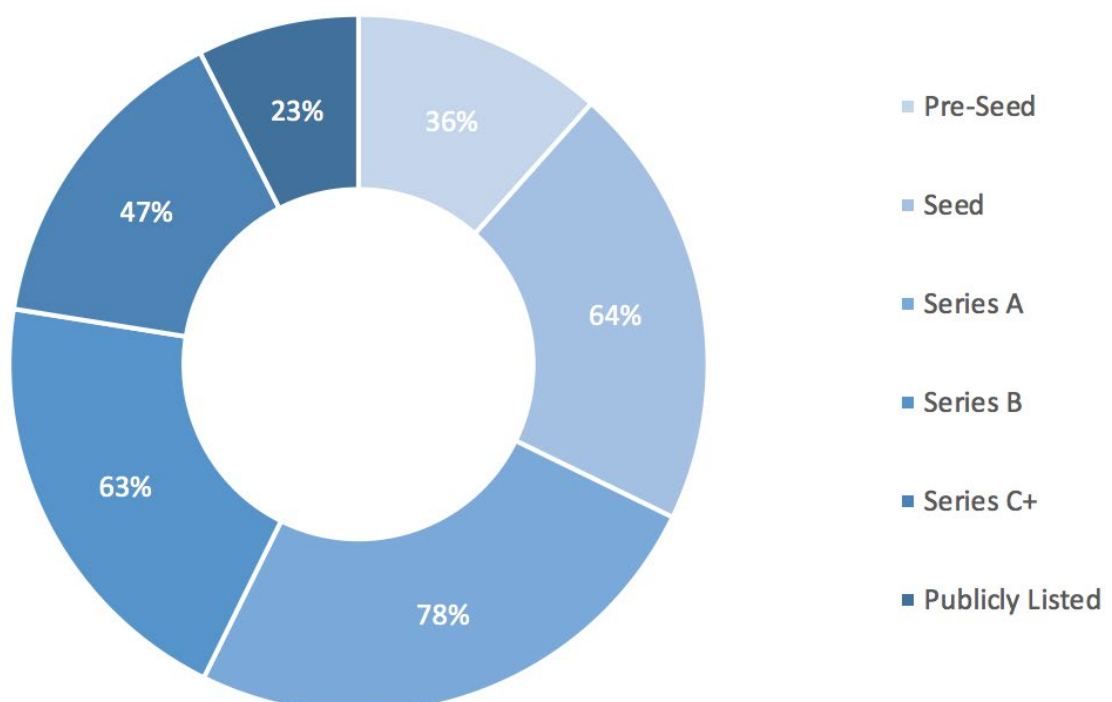

What developmental stage(s) of company interests you?

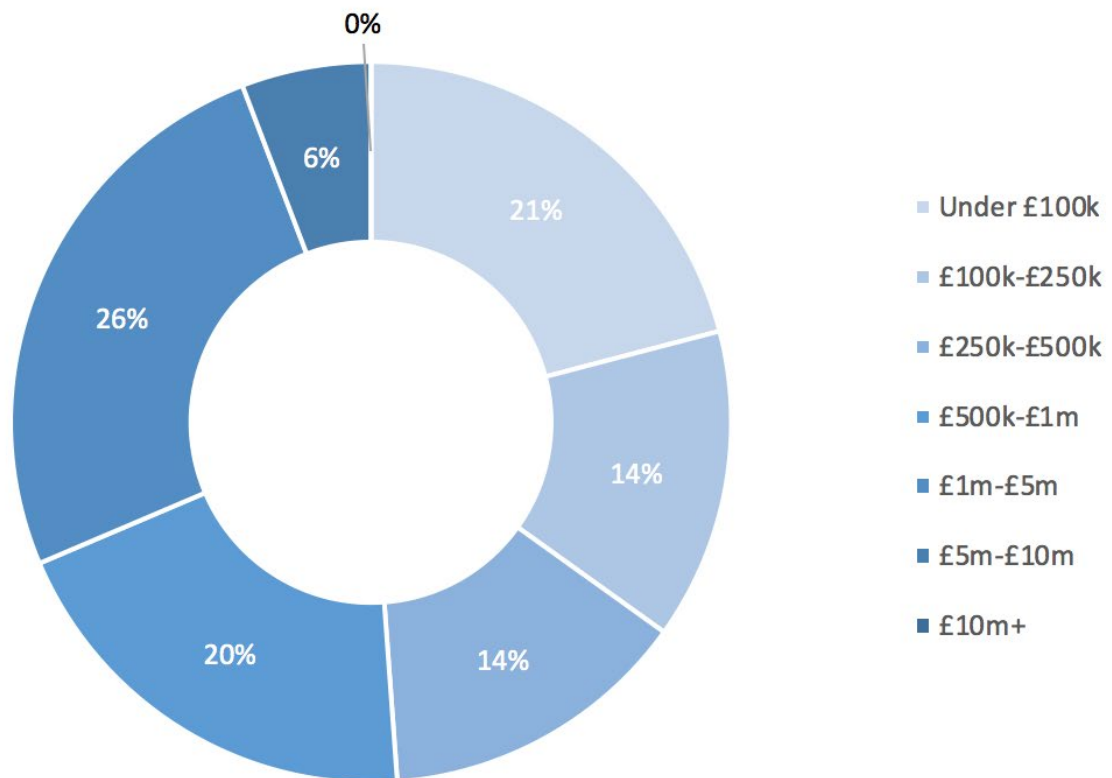


What capital stage(s) of company interests you?

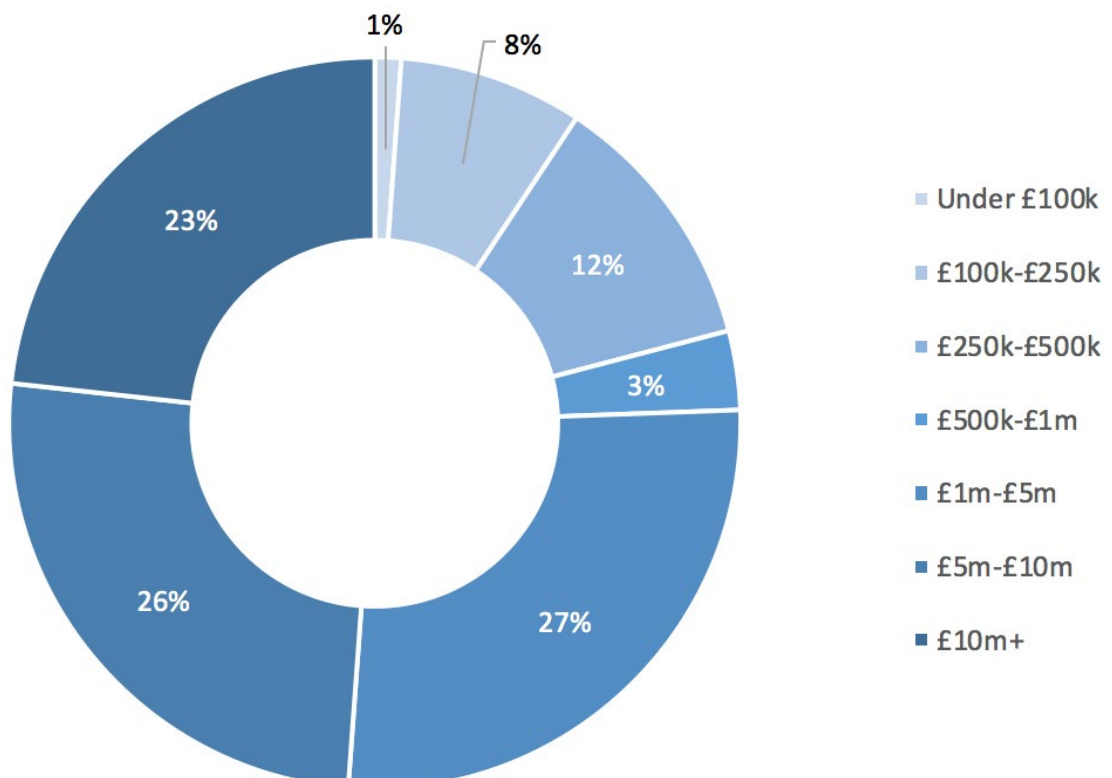

What is your minimum investment size per round?

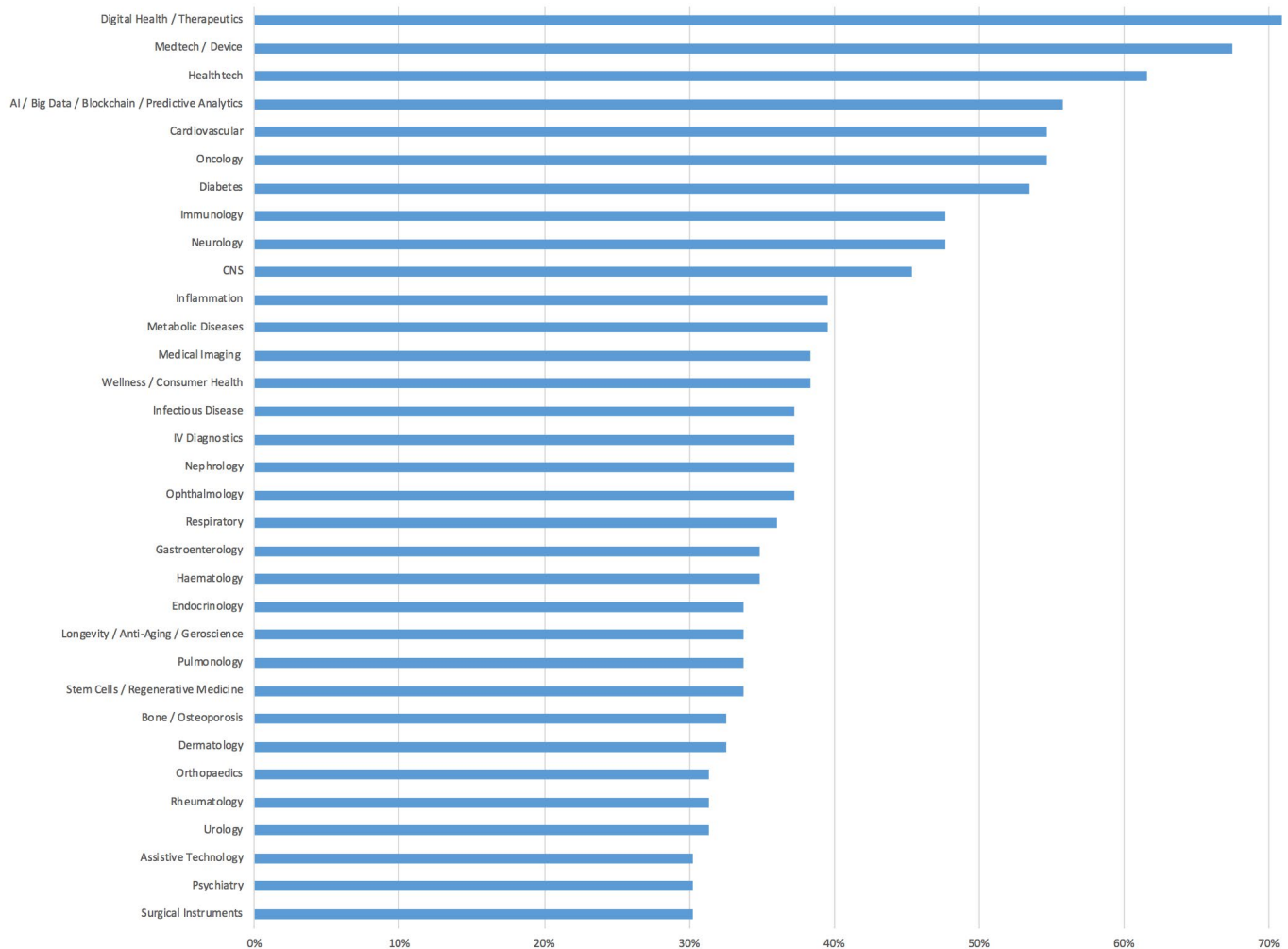


What is your maximum investment size per round?

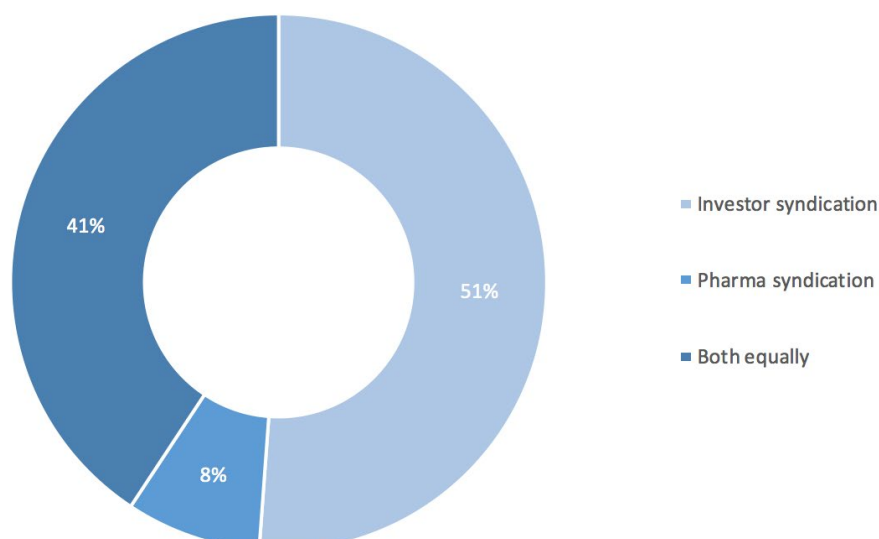
